ENTRIES, GREEN FOR 4-H ENTRIES & BLUE FOR FFA ENTRIES

DEPT--REFER TO THE PREMIUM BOOK, WHAT ARE YOU ENTERING?

CLASS--WHAT AGE ARE YOU? ie, IF YOU ARE AN ADULT, YOU ARE CLASS 9, IF YOU HAVE ENTERED AS A 4-H OR FFA REFER TO THE PREMIUM BOOK

NAME OF EXHIBIT--WHAT IS YOUR EXHIBIT? ie, BEETS, BLUE NECKLACE, SKIRT, CHOCOLATE BROWNIES, etc.

DIVISION--REFER TO THE PREMIUM BOOK. FIND A CATAGORY IN THE APPROPRIATE DEPARTMENT FOR YOUR EXHIBIT. IF YOU HAVE BEETS, YOU GO TO DEPT 35 AND DIVISION 1 (BEETS ARE A VEGETABLE)

SECTION--IF YOU HAVE LISTED YOUR DIVISION AS 1 FOR VEGETABLE, THE SECTION MORE SPECIFICALLY DESCRIBES YOUR ENTRY. IN THIS CASE YOUR SECTION WILL BE 2.

LOT--IS AN EVEN MORE THOROUGH WAY TO DESCRIBE YOUR EXHIBIT. DEPENDING ON WHAT KIND OF BEETS YOU HAVE, PICK THE CORRECT LOT NUMBER THAT BEST DESCRIBES THEM.
