RULES:

1. Entries for displays and booths **MUST** be in the Fair Office by 9 PM Wednesday.

EXHIBITORS must contact the **FAIR OFFICE** prior to this date for an assigned display space.

2. Booths and displays may be set up starting on Tuesday, August 18, and will be left up until Sunday, August 23 at 9:00 AM.

3. Exhibit form **MUST** name the building and location where the display is located. **Stall and pen decorations are excluded from being judged.**

4. Entry blank **MUST** have exhibitor's name, number, class **AND** the title of exhibit.

PLEASE PRINT NEATLY!

5. All exhibits **MUST** have exhibitor tag complete with name and exhibitor's number, attached to display or booth. **EXHIBITS WITHOUT AN EXHIBITOR'S TAG WILL NOT BE JUDGED!**

6. Divisions 2 and 3 will be judged on the Danish Award system.

7. Displays or any part thereof, may not be entered in any other department. **EXCEPTION:** Any exhibit may be used in a 4-H or FFA demonstration.

8. **Table top display should not exceed 24" x 36" and be self-supporting. See Dept. 2 rule #5 for other display size.**

9. Booths & Displays **MUST NOT** have been entered in previous years.

10. Adult exhibitors receiving white ribbons will only receive ribbons, but no premium money.
