RULES:

1. Exhibitors must read General Rules, Livestock Rules, LC Fair Jr. Livestock Sale Rules and Health Regulations before filling out entry form.
2. Each exhibitor will be required to participate in barn duty each day. Premium money may be withheld from exhibitors who choose not to participate in barn duty.
3. Exhibitors will be responsible for decorating their own pen(s). An educational poster is required.
4. Exhibitors are responsible for their own feed.
5. Availability of pens for open class will depend upon number of exhibitors and discretion of superintendent.
6. Only does and wethers may be shown. **No bucks allowed!**
7. **All Fitting and Showing Classes may be shown together.** The Grand or Reserve Champion exhibitor in the Fitting & Showing class in Market, Dairy & Fiber goats will compete in the Round Robin in the large animal division with Horse, Steer, Hog & Lamb exhibitors. The Pygmy goat Fitting & Showing Grand Champion or Reserve exhibitor will compete in the small animal Round Robin Division with Poultry, Rabbits and Cavies.
8. No cross entry between Open, 4-H, or FFA in Fitting and Showing.
9. In the breed classes, goats must be shown in an individual lot to be shown in group lots.
10. **Goats in the breeding classes must have their horn tips covered as a safety precaution.**
11. Market goats must be under one year of age by evidence of milk teeth.
12. **Goats under 60 lbs will show in the feeder class and will not be eligible to sell. Any goats over 115 lbs will go in heavy weight class and are not eligible for championship class.**
13. If a goat is exhibited in Division 8 (Pet Goats), it may not be exhibited in Fitting and Showing or a breed class.
14. Each class of livestock will be judged separately by weight. Each division, 4-H, FFA and Open will be judged separately.
15. **All exhibitors must help take down pens and be cleared by Barn Superintendent before leaving.**

****ENTRY FEES**\$5.00 A HEAD**

RULES:

1. **ALL 4-H MEMBERS ARE REQUIRED TO WEAR ASTM/SEI APPROVED HELMETS IN ALL 4-H MOUNTED/DRIVING ACTIVITIES (EXHIBITING, PRACTICING, OR WARMING UP.)**
2. Exhibitors will read General Rules, Livestock Rules, 4-H Horse Policy, FFA Rules and Health Regulations before filling out entry forms.
3. All 4-H and FFA horses must be stalled on the fairgrounds by 8 PM Wednesday to be eligible for exhibit and competition. 4-H horse clubs and FFA chapters will have barn priority.
4. No colts or stallions allowed in 4-H.
5. Divisions 1-3 open to Lincoln County 4-H club members and FFA chapters only.
6. **NO HORSES ON MIDWAY.** Forfeiture of premium money if horses are on the midway.
7. Tack boxes are not permitted in main aisles of barns.
8. Do not saddle horses in the aisles or in the stalls. Do NOT tie horses in the stall or aisles. Do NOT leave horses saddled in stalls.
9. Lead horses from barns to holding areas and arenas.
10. Hang water and/or grain buckets in stall.
11. No hay nets/grain pans in stalls after 8 PM.
12. Dump manure only where posted.
13. Divisions 4-7 stallions/jacks must be shown only by adults, 18 and over.
14. Open class horses may be brought in anytime up to show time.
