RULES:

2. Judges will score according to score sheets and 4-H standards.
3. A best Record Book "4-H Story" from each division (except primary) will be chosen for a special prize.
4. **Due to safety concerns, home addresses should be left off of the front pages of the Record Book. Complete all of the other information.**

FFA RULES

This department is open to only regularly enrolled students in Vocational Agriculture or members in good standing in a chapter of Future Farmers of America. **NEW this year FFA is open to exhibitors in other counties besides Lincoln County.** All FFA exhibits and contests will be judged by the Group Award System, except booths.

IMPORTANT: Exhibitors need to read General Rules, Livestock Rules, Jr. Livestock Sale Rules, and Health Regulations before filling out forms. Exhibitors to furnish feed and water containers. Check with Barn Superintendent to see about bedding.

DRESS CODE: FFA members must show in official dress consisting of black pants, white collared shirt, FFA tie or scarf and FFA jacket.

EQUINE DRESS CODE: All FFA equine exhibitors must abide by the WAHSET rules. All exhibitors must wear an ASTM/SEI helmet, properly adjusted according to manufacturer's instructions while mounted. The required uniform consists of a solid polo shirt with collar, long sleeve, rolled down to the wrist, and shirt tucked in; solid color western style pants or jeans OR English breeches or jodhpurs and appropriately corresponding boots for the style of riding and tack used. Boots must have a definite heel - no ramps are allowed. Exhibitors with long hair need to wear it neatly so that their number is clearly visible.

NOTICE TO FFA EXHIBITORS: Premiums, sections, and lot numbers will be the same as listed in dairy, beef, sheep, swine, poultry, rabbits, grains, grasses, weeds, fruit and vegetables, and floriculture.

NOTE: All rules governing qualifications and standards for exhibits in open classes apply to this department. Judges will follow the same rules in awarding premiums and ribbons.
