

# PARKING AND CAMPER REGULATIONS

**ALL persons using the campground facilities MUST have a season pass**

**PRIOR TO FAIR** loading and unloading of cars and trucks on the grounds is permitted without charge, provided they are driven outside the gate as soon as the tasks are completed. **DUE TO LIMITED PARKING FOR OUR FAIR VISITORS, THE REMAINING EXHIBITOR LIVESTOCK TRAILERS ARE TO BE PARKED AT THE NORTH AIRPORT PARKING LOT.**

Horse trailers, one per club will be parked in the designated area assigned. Only those campers, trailers or motor homes using water or electrical hook-ups will be allowed in Area 29. All other RV's will be parked in Area 30 (see Map of Fairgrounds).

**THERE WILL BE NO PARKING OF CARS OR PICK-UPS ON THE FAIRGROUNDS, WITH THE EXCEPTION OF THOSE USED OFFICIALLY**

## RV CAMPGROUND RULES

1. **NOTE:** Campground application from this book must be mailed in to reserve a space.
2. All youth using campground facilities must be chaperoned. If not staying with a parent, name and age of chaperone must be provided to the persons in charge of the facilities. Any camper or trailer without adult supervision during the night will be removed from the campground.
3. **All season passes** must be purchased by **AUGUST 7th** and on file for persons listed on the form.
4. **NO** vehicles except the RV or tents will be allowed in the camping area inside the fence.

**Campers with personal vehicles need to park in the north parking lot at the airport, not in the fair parking lot. VIOLATORS WILL BE TOWED!!!!**

5. 31 hookups with sewer are available for campers or trailers. There is not enough space for tipouts in this area.
6. **Fire lanes between the rows of camping units must remain open at all times for emergency access and fire protection.**
7. No air conditioners are to be operated from the Fairgrounds power. Use of generators after 10:00 PM is not allowed.

8. Restrooms and showers are available. Keep restrooms and campgrounds clean.
9. **ALL** pets must be kept inside RVs or campers. **NO** dogs are allowed tied up at campsites. **NO** dogs allowed on the midway, buildings, barns or grandstand area. **You will be responsible for cleaning up after your dog. NO BARKING DOGS IN CAMPGROUND AREA.**
10. Tipout RVs are not to be parked in the full hook up area.
11. The Lincoln County Fair assumes no responsibility for damage or injuries to campers and/or camping units.
12. **NO REFUNDS!!**

The above-stated rules are for your protection and convenience, as well as to provide emergency information and location for Fair Board personnel. Payment of fees constitutes acceptance of campground rules for all adults and minors using the campground.

## CHARGES FOR CAMPING

### INCLUDE SALES TAX

**\$75.00—Full Hook-Ups (including sewer)**

*No Tipouts in Full Hookup Area*

**\$60.00—Electricity and Water Only**

*Tipouts must not extend beyond assigned space.*

**\$50.00—Inside Electricity Only**

**\$40.00—No Hook-Ups/Maximum Length**

**For tent trailers-22 ft. (tongue to bumper)**

**\$25.00—Electricity Only—out the back gate**

**\$20.00—Tent Camping Only**
