## *Rules of the Lincoln County Fair*

- ✦ This agreement considers long-term for any camping over 30 days.
- ✦ Only motor homes, fifth wheels and travel trailers will be allowed for long term camping.
- ✦ Quiet hours are from 10:00 p.m. to 6:00 a.m., at this time all campsites are closed to all persons except registered campers.
- ✦ Loud noises from sound equipment or vehicles will not be allowed at any time.
- ✦ Individuals who are boisterous, rowdy, disorderly, intoxicated, or otherwise disturb the peace at any time may be requested to leave the campground.
- ✦ Contained charcoal grills/gas grills for cooking are allowed. Open fires are NOT permitted.
- ✦ Keep the area surrounding your campsite clean and neat.
- ✦ All refuse must be deposited in trash container located by the Main Building.
- ✦ No littering, this includes cigarette butts.
- ✦ No wastewater permitted to be dumped on Fairgrounds.
- ✦ Camping is permitted in designated camping areas only.
- ✦ Only one camping unit and one vehicle per campsite. Extra cars may park in parking lot.
- ✦ Pets are allowed and need to be leashed at all times when not in vehicles, trailers or campers.
- ✦ Do not allow your pets to roam freely while on the Fairgrounds when livestock or horses are on the property, including the arena.
- ✦ Clean up after your pets and dispose of properly.
- ✦ No person under the age of 21 shall possess or consume alcoholic beverages while on the Fairgrounds.
- ✦ Responsible adult(s) will be held liable for any vandalism by minor children and will be required to pay for any damages.
- ✦ The Lincoln County Fair is not responsible for accidents, injuries or loss of property by fire, theft, wind, vandalism, or Acts of God.
- ✦ Lincoln County Fair may remove or cause to be removed from the campground any camper or guest or other individual who, while on the premises of the campground, disturbs the peace and comfort of the other campers, who causes physical harm to the campground facilities, or who fails to pay rent at the agreed rate by the time agreed upon. Lincoln County Fair may also disconnect your utilities, place a lien upon property, place your property in storage, or take other actions as provided by law.
