- ✿ Pay for damage caused by horse(s) to stalls during short-term stay at Lincoln County Fair.
- ✿ Stall fees are for stall or pen use only and does not include bedding, cleaning of stall or care of horse.
- ✿ Only one horse per stall or pen.
- ✿ Stalls or pens will be cleaned for users to move into. User must clean stalls or pens when vacating the Lincoln County Fair.
- ✿ No altering of any stalls or pens is allowed. Stalls or pens to be returned in same condition as received.
- ✿ Stalls or pens will be kept clean at all times during the rental period.
- ✿ All horses must be treated and cared for humanely while on the grounds of the Lincoln County Fair.
- ✿ Lincoln County Fair will investigate any negligence reported.
- ✿ Stall or pen waste and waste from horse trailers must be disposed of at designated sites.

By completing and signing the Lincoln County Fair Horse Stall Rental Agreement, you are certifying you have read, understand, and will adhere to all rules and policies herein. The Organization or Event Coordinator agrees to indemnify and hold harmless the Lincoln County Fair from and against any loss, expense, claims, damages, causes of action, injuries, suits or damages, suits to person or property, including attorney's fees, arising out of or related to the operation of the rental of the horse stalls or pens.
