Panels are available in Harrington from Evert Cole for the use of making a ring for the Livestock 'Show. Mike and Dennis are responsible for getting the panels.

Ed Haight is the Fair Commissioner who will be here during the Fair.

KNCW from Coulee Dam will be broadcasting from the grounds during the Fair. A motion was made and seconded to pay \$240.00 for advertising with KNCW before the fair, (we would have 10 Total Audiance Plays per day for this amount of money)

Motion carried.

NB will be giving us free night deposits during the fair, and an employee to help with counting money from the gates.

It was desided amoung the members to send a sympathy card to Kathy Lungrens' folks and a collection was taken at the meeting for the 4-H Scholarship. (that memorials are being used for) \$30.00 where collected.

We discussed the dishwasher, which Carol Crosen donated, coming up with the decision that we would talk to Larry Lindbloom and see if there were funds available to replace the 3 phase motor with a single phase motor.

A motion was made and seconded that if there are monies available that we will replace the motor, but if there are not we will have to wait until after the Fair, Motion carried.

Dennis has found display cases for the Grain Growers. Open Shleves would display the grain and vegetables much better. Dennis will be responsible for getting them and returning them after the fair

Dave has found some chips for the livestock bedding. They are the Lincoln Mille in Wilbur. Mike will get in touch with John Watson, the superintendent, and arange a day to get them hauled over to here.

The scales were not able to authorised according to Orville. Donna asked if she couldn't handle that and get in touch with the right people. She was given the O K to do so.

The Mini "Arena will be fensed and lighted before the Fair.

The city will have extra dumpsters here on the grounds during the Fair.

A motion was made and seconded to have the Putt Putt Golf Course moved to the

other end of the Fairgrounds, by the 'carnival area. Motion carried.

A motion was made and seconded to have Old MacDonalds Farm in the new horse barn this year only. Motion carried.

The painting will be done next week. And new pipe in the mini arena will be drilled into the ground for the fense line.??

Jerry Gorden brought something to our attention about the livestock. There seems to be some controversy about the lengthh of time you should own your steer. It will be something to consider in the future before next years fair.

The bills were presented at the total of \$3,089.98. A motion was made and seconded to pay the bills presented. Motion carried.

Being no further business, the meeting was ajourned until Wednesday, September 15, 1982.
