Kathy Lucht has drawen an ad for the Horse Sale that is going to be held the 8th of May. The flyer will be given to the secretary and copies will be made by the mend of the week. Bob Martin has contacted an auctioneer. It was discussed that we should obtain a contract with the auctioneer so that the cost doesn't jump up after the sale is complete. Also we meed to add a line on the ad stating that cash or a letter of credit is necessary for the purchaseing of an animal.

There was some discussion about the bleacher materials. The lumber that was previously sugessted to be purchased was already gone when we got back to Crow Z. So we are going to have to purchase the lumber from the next lowest company. It was also discussed that Richard Hayes was elected to the board, and has never attended a meeting. It was the concesious of the board to disregard Richard hayes and appoint Mike Stormp to the board.

It was also discussed that we should check the prices of tents or shelters for the showing ring in-th- next to the beef barm. Possibly more kids would show if it were sheltered.

John Wagner gave a report about the entertainment forthe fair. We have received a contract for a carnival that has kiddie rides. We would receive 15% of the take. It was decided to wait and see if we can get enough 3 phase power for a larger carnibal beforw we send the contract back. We will also have the kiddie tractor pull, with help from Gene Stuckel and a kiddie scramble, with help from Ron Ensor. Nail driving contest and other contest were mentioned with no real disision. Gene Stuckle has offered to give a 30 minute plame ride for a prise to one pf the contest. We also decided to hire Boden and Zenetto back again this year. Not that many people daw them and it would be something different/.

Carol Crosen keld a meeting with the Princess from last year, and made some new rules that needed to be discussed. One thing that was brought up was that the Fair should provided a crown and sash for the 8 princesses that they can keep instead of buy the girls matching outfits. But to do this the account for the Chaperone needs to be opened now. A motion was made and seconded to ask for the Chaperone account to be opened. Motion carreid. We also kiscussed the securtly of the Roylaty Room. Mike said he would make sure the lock was put on the door proberly and that some metal boxes would be made for the room for the girls to put their vaulables in, under the condition that the girls supply their own locks.

There was some discussion about the time of the meetings. A motion was made and seconded to have the meeting time moved back to 7:00 pm on the third Wednesday of the month. Motion carried.

John also brought up the fact that there are 18 board members on the board, when it was already voted on to have 15. So a motion was made to disregard the previous motion and a motion was made and seconded to have a 18 member board. Motion carried. This is for the by laws, which John is working on. We also Made a motion that the president is limited to a 2 year consecutive term. Motions seconded and carried.

It was also discussed that we should have a ventalation fan and hood in the kitchen over the grill. A motion was made and seconded to have Mike check into purchasing a hood and fan for the kitchen. Motion earried. And there was some discussion about having already set a price for a damaged deposit, and that we should collect it from Mrs. Dertick. The decision was to hold a check for the amount of \$100 and if every thing is in the same condition the clasck will be given back to her.

The bills were presented in the amount of \$912.92. A motion was made and seconded to pay the bills.

Being no further business the meeting was ajourned until the 16th of March at 7:00 pm.
