

**LINCOLN COUNTY FAIR ADVISORY BOARD
NOVEMBER 20, 1998**

MEETING WAS CALLED TO ORDER BY PRESIDENT OVERMYER. MINUTES OF THE LAST MEETING WERE READ AND APPROVED.

IN ATTENDANCE WERE: LYDIA, BILL, ANNE, GERRY, LEIGH, JOSIE, MAGGIE AND KAREN. FIRST TIME THIS YEAR EVERY BOARD MEMBER WAS IN ATTENDANCE.

ANNE CALLED AIRWAY HEIGHTS CORRECTION CENTER TO SIGN UP FOR A CONTRACT UNDER THE FAIR TO GET INMATES TO WORK ON THE GROUNDS NEXT SUMMER. THEY HAVE ASKED WHAT DATES WE NEED THEM. WILL ASK FOR 3 WEEKS.

A LETTER WAS READ FROM FRUITS AND VEGETABLE SUPT. CHARLIE KRINGEN ASKING FOR EXTENDED HOURS ON FRIDAY AND SAT. NIGHTS. THE BUILDINGS WILL BE KEPT OPEN UNTIL 10:00PM ON FRIDAY AND SAT. NIGHTS FOR THE PEOPLE ATTENDING THE EVENTS IN THE ARENA.

THE STATE JUDGE SUGGESTED WE SEPARATE OUR JUNIOR, YOUTH, ADULT, 4-H AND FFA ENTRIES IN THE DEPARTMENTS THAT HAVE ALL CLASSES. SHE ALSO HIGHLY RECOMMENDED MOVING THE JUNIOR BAKING AND CANNING TO THEIR RESPECTIVE DEPARTMENTS. KAREN WILL WRITE A LETTER TO LOIS.

AT THE STATE CONVENTION THE ONLY ENTERTAINMENT BOOKED WAS FOR TAMMY THE HYPNOTIST FOR AUGUST 27 AND 28 FOR \$1500.00. JOSIE WILL HEAR IN JANUARY IF THE CARNIVAL IS COMING OR NOT.

STATE FUNDING WAS DISCUSSED. WON'T KNOW UNTIL JAN. OR FEB. IF THERE WILL BE ANY FUNDING FROM THE STATE. COMMISSIONER HOPKINS HAS WRITTEN SOME LETTERS ASKING LEGISLATORS TO MAKE FAIR FUNDING A TOP PRIORITY WHEN THEY MEET IN JANUARY.

JON SAID HE THOUGHT HE COULD GET SOME OLD MACHINERY FROM THE MUSEUM TO DISPLAY ON THE GROUNDS DURING THE FAIR.

THE DAVENPORT FLOAT HAS BEEN STORED IN THE BEEF BARN. NO ONE GAVE PERMISSION FOR IT TO BE THERE AND THE SPACE COULD BE RENTED. WILL CONTACT THEM WITH A BILL, THERE IS NO FREE PARKING ON THE FAIRGROUNDS.

SUGGESTION MADE TO PUT A LISTING OF THE ENTERTAINMENT FOR EACH DAY BY THE GATES.

LCLC 4-H CLUB WILL BE DOING SOME WORK TO BEAUTIFY THE BANK BY THE BACK GATE.

JON WILL FIGURE A PRICE FOR MATERIAL FOR 4-5 BLEACHERS. MAYBE A LIONS CLUB WOULD BUY THE MATERIAL AND FFA STUDENTS BUILD THEM.

LYDIA ASKED ABOUT SOME SUGGESTIONS FOR ADDING FREEZER JAM AND BREAD MACHINE BAKING TO THE PREMIUM BOOK. WILL FIGURE OUT A DESCRIPTION TO PUT IN THE BOOK.

GERRY HAS BEEN TO BUDGET HEARINGS AND THE COMMISSIONERS HAVE SUGGESTED CUTS FOR 1999. WE WILL BE RECEIVING \$12,500.00 FROM THE COUNTY FOR 1999.
