Patti W. asked to have Ladies Lead moved up one hr. prior to the sale, and start promptly on time.

Subject came up an Ribbons and Trophys, the Fair board would be responsible for the Ribbons and Judge or Judges, and the 4-H people would be responsible for trophies. Patti would get the Trophies. Rezeau moved to adopt Patti's recommendations, 2nd by Sox and carried.

The Board discussed weather the Rabbits are a part of the Round Robbin, and they decided there are really no rules for this, so this would include Rabbits. Tom moved we adopt this recommendation, for Round Robin showmenship, 2nd by Steve.

A letter of recommendations from Cal R. was read for the livestock judges, it was so moved to accept these recom. by Sox, and 2nd by Rezeau. carried.

All of the recom. for superintendents were approved by the board except for the Beef area, which will be comfirmed at a later date by Board of Director Steve Randel, moved by R.M. 2nd by Tom W. carried.

Dairy Goat recom. for premium list by Pat Holister, she would like the goats to be judged in the morning instead of the afternoom, since they are not milked before showing. Sox moved we adopt recom., 2nd by Tom W. carried.

Esthmer Kik mailed in her recom. and it is recorded on tape, and Rezeau moved we accept these recom. 2nd by Orville W. carried.

Spokesmen for the Cattlemen's Assoc was Cal Ransom, he said there was a Contest being sponcered by the Cattlemens Assoc. and that they would like to have inserted behind the Carcass Evaluation Progress for the Premium Book a Weight gain per day, Cal had guidelines and will have them typed up and turned into the Fair office. Sox moved we accept and it was carried.

Patti W. would like to have an Old Mac Donald's Farm, the Chrm. suggested she type up her recommendations and turn them in the way she wants it put into the premium book, Stev moved we have an Old Mac Donalds Farm, 2nd by Sox. carried

Francis Douglas turned in her resignation to the Fair Board, she felt she did not have the time, Sox moved we accept her resignation, 2nd by Rezeau. carried.

John requested to ask Dennis Herdrick to be on the Board, there were no objections from the board.

Tom moved to have the councilers pay the same price as the4-Her's
