The Board agreed. Spec. will be drawn up for the bidding of the auditorium.

Recomm. were accepted for the Horse, Sheep and 4-H.

Patti W. questioned if there would be prem. pts on the Old Mac Donalds Farm. Rezeau said this would be judged as Educational Booths. Prem. pts. commensuiate with the Youth Organ.

Booth , page 16 and list in the 4-H area pts. are the same.

The Commerical booth space was raised to \$50.00, it was moved by Rezeau and 2nd. by Shirley The 4-H Youth Council requested to use the Hambuger stand for the Springfair. Rezeau moved to allow the 4-H Youth Council the stand with the stipulation that it is cleaned up when they are finished. 2nd. by Sampley Carried.

Carol requested to go to Puyallup for Sec./Mge's meeting, Shirley moved to allow her to go 2nd by Orville-Carried.

Entertainment for the 1981 Fair was left up to the Sec. to select.

The need for a new freezer was discussed and at this time Western Auto had a sale on them. However the Board felt that the 5.3 cu. ft. was insufficent and decided that the 15.3 cu. ft. was the way to go. Rezeau moved to purchase a 15.3 cu.ft. freezer 2nd. by Shirley. Passe Also a need for a ladder was brought up, it was moved by Shirley and 2nd. by Rezeau to buy an aluminum A framed ladder. carried.

Dorothy Dormaier from Medical Lake, would like to be a permanet part of our Fair functions The Board said this group would have to transfer everything over to Lincoln County. It was suggested to postpone this until the next meeting.

It was suggested to charge the 4-H camp a flat fee, Chrm. Wagner stated there wasn't any payment made for the use of electricity. Rezeau moved to postpone this until the next meeting.

A sign up sheet was passed around for a clean-up day on April 4th and the 11th, however this died for lack of INTEREST.

Tom moved to adjourned. Carried.
